"Justice and Power must be brought together, so that whatever is just may be powerful, and whatever is powerful may be just" Blaise Pascal a great French scientist long time ago said that wonderful phrase, The Federal Republic of Yugoslavia in the last 30 years and through all of its presidents has adopted the policy of justice and equality to prevent the situation we are now living, ethnic integration during the whole Yugoslav history, especially in the Serb background, has been one of the ultimate goals as a Federation. The international community sees Yugoslavia as a state that hates certain population and that oblivion is the goal it seeks for that community of Kosova-Metohija.

Yugoslavia in the other hand has the proofs that such accusations are totally false the evidence starts from the 1974 Federal constitution that sought ethnic integration from all parts of Yugoslavia followed by the 1990 Constitution of Serbia that establishes equality and freedom as main principles for all citizens across all articles, as an example, we have article 1 of the last Constitution that states: "The Republic of Serbia is a democratic State of all citizens living within it, founded upon the freedoms and rights of man and citizen, the rule of law, and social justice".

Throughout 1948 to the present time we have established the laws and accords that Yugoslavia and Serbia defend for the purpose of the principles in our constitution, but still some questions remain, Is the international community going to forget the Third article of the Second protocol of the IV Geneva convention? Is it going to put aside the Guiding Principles of the Helsinki final act? Is it going to ignore the Dayton accords? Or are they not going to pay attention to the actions the Kosovo Liberation Army (KLA) is taking to prevent the success of the Belgrade agreements? Or are they forgetting that the Albanian Kosovar Leadership never condemns the terrorist acts the KLA makes?

Yugoslavia's responsibility to protect its citizens is not over yet, neither will it surrender the fate and security of it citizens to a humanitarian intervention that is destined to fail and to be worse than the disease they are crusading to eradicate. Yugoslavia will accept a peacekeeping operation with the real composition that the Capstone Doctrine and the Petersberg tasks withstand under the concept of collective security and rejects the use of collective defense the NATO (North Atlantic Treaty Organization) tries to practice in our soil.

Yugoslavia and Serbia bring towards this conference their will to accomplish the demands that are legal to accept such as the fulfillment of the resolution 1199 of the Security

Council, the Belgrade agreements of 1998 and to further discuss other measures to control the escalation of the situation and the non-negotiable principles that Ambassador Christopher Hill, US Special Envoy to Kosovo, brought towards us in the name of the Contact Group.
